The project studies legal engagement as a strategy for refugee protection using international case studies (Egypt, India, Malaysia, and Hong Kong SAR). The problem (eg. specific challenges in protecting refugees) and the studied solution (eg. legal engagement) are particularly relevant to international jurisdictions in the Middle East and Asia.

The main objectives of the project are as follows:

(1) The project takes as its point of departure the inadequacies of and the need for an alternative to the current ad hoc, extra-legal approach to protection in the large number of states in the Middle East and Asia which do not adhere to the treaties of the international refugee regime nor have domestic legislation to protect refugees. The proposed alternative is the "law of asylum": the creative use by local legal actors of existing legal frameworks, processes and institutions to provide protection to refugees. This approach will be tested in the challenging jurisdictions of Egypt, India, Malaysia and Hong Kong.

(2) The project seeks to map the local legal frameworks that are available for the protection of refugees through the law of asylum, to validate these frameworks (and the problems that they address) with local refugee and legal communities, and to test the utility of these frameworks through sustained legal engagement (30 legal encounters in each case study jurisdiction).

(3) The project seeks to provoke a sustained discussion about legal engagement in the Global South. This discussion will be provoked and informed by the following key interventions: (i) online discussion of the findings of the project and the legal encounters represented by the 40 digital stories produced by the project; (ii) national / regional workshops to share the findings in the Middle East, South Asia, South East Asia, and East Asia; (iii) scholarly and practitioner outputs, including journal articles, a practitioner-focused edited collection, a monograph, policy briefs and guidelines; and, (iv) engagements with scholarly and practitioner communities at a number of key meetings, in London, Geneva, Bangkok, and elsewhere.

(4) The project seeks the reformulation of policies with respect to protection in the Global South to include a focus on the use of legal engagement strategies even where the Refugee Convention and other traditional indicia of refugee law are absent and where the rule of law may be problematic. Advocacy for this goal will be supported by the production as part of the project of 40 digital stories about legal encounters in the four jurisdictions studied by the project. In addition, the project will produce policy briefs and guidelines for various stakeholders.

(5) By working closely with local providers of refugee legal aid in each jurisdiction and high-profile advisory board, the project will create cohorts of practitioners well versed in the discourses of refugee legal aid and with strong international support networks. The project will support and strengthen existing networks such as the Asia Pacific Refugee Right Network through partnership with its Legal Aid and Advocacy Working Group.
